1. Purpose and Commitment

Thorough identification and monitoring processes are in place to prevent any involvement with unacceptable payments.

The confidentiality of CBK's business-related information and personal data is paramount. We handle information, IT systems, and internet services responsibly and professionally. We are committed to respecting individual privacy and complying with relevant data protection laws.
